## *Western Springs Police Win Statewide Traffic Safety Awards*

It is still possible to make a huge difference within a community even though your police department numbers fewer than 25 municipal sworn officers. That is the case in Western Springs. **Recently the Department was notified by the Illinois Association of Chiefs of Police that they placed first in the "2008-2009 Illinois Traffic Safety Challenge." In addition, the Western Springs Police Department was also named "Rookie of the Year" and won the "Pedestrian/Bicycle Safety" award.**

**The Illinois Traffic Safety Challenge is a statewide highway safety program that recognizes law enforcement agencies for their efforts in addressing traffic safety issues in their jurisdiction.** All applications for the recognition are judged by a panel of highway safety professionals. Throughout the state, drunk drivers are removed from the road, individuals are slowing down, more people are clicking their seat belts, and even fewer drivers and passengers are being injured or killed in crashes.

**Western Springs Police Chief Pamela Church noted, "On behalf of the Western Springs Police Department, I am truly honored to accept this prestigious recognition. I am very proud of our officers' traffic enforcement efforts in making this a safer community."** She will officially accept the awards on August 12, 2009, at the Midwest Police and Security Expo at the Stephens Convention Center.
